But, many see them as invasive and ripe for abuse by government over reach. When a local government proactively explains, engages, and informs the public about its intended use of unmanned aerial systems, the result can be a win for law enforcement and the community. In this presentation, Brookhaven Police Lieutenant Abrem Ayana will discuss the mechanics and uses of DFR in support of law enforcement and de-escalation of police-citizen encounters. Brookhaven City Attorney Chris Balch will demonstrate how engaging and seeking out input from advocacy groups, prosecutors, and the community can establish the dialogue necessary to have new police programs embraced by a suspicious public. Materials will include the DFR Policy developed and adopted by Brookhaven, examples of the program in action, and discussion of how to navigate the lack of clear court direction when establishing a DFR program. 10:45AM to 11:45AM	Blue Room	The Escalation of Abusive State Preemption in 2023	As state legislatures have become increasingly polarized over the past decade and a half, there has been a dramatic rise in "new preemption." Once used sparingly to maintain consistency on areas of statewide interests, state preemption is increasingly infringing on a range of traditionally local issues, including municipal budgeting, public health and safety, county election administration, local law enforcement and more. These abusive state preemption laws stem from reactions to topical political issues, but have long-term ramifications for local governments' ability to execute basic functions.  The Local Solutions Support Center (LSSC) has been tracking abusive state preemption nationwide—including over 1000 bills in the 2022 legislative session—and observing trends salient to the 2023 legislative session. In particular, LSSC has no ted an increase in preemption related to equitable housing policies, prosecutorial discretion, reproductive rights, LGBTQ+ rights, and other topics.  This session will brief attendees on emerging and escalating trends at the mid-point in the 2023 legislative session, legal questions they give rise to, and their long-term ramifications. This session will also equip local government attorneys with the tools and guidance they need to support and protect local democracy in the face of abusive state preemption.
