Guest Cancellations are subject to a \$25.00 administrative processing fee. All refunds will be remitted 90 days after the event. In the event of a refund, any associated credit card fees that IMLA collected will not be refunded. Discounted registration fees expire 15 days after the applicable rate ends. If full payment is not received, the next rate will apply. The discounted registration fees are available for those staying in IMLA Event Hotel, otherwise \$100 will be added to your registration fee to help defray IMLA event expenses (local attendees exempt from \$100). Event payment must be received within 15 days of registration. The registration you are purchasing is for an in-person program. In the event that our on-site event is canceled, and we will transition to a full virtual event, but programming times and dates will change. The registration is refundable up to a month before the event. All cancellations are subject to a \$75.00 administrative processing fee. If the in-person event is cancelled and pricing is altered the difference in cost will be applied to your member account and you will be automatically registered for the fully virtual event, unless you contact IMLA for cancellation.
